This ADOPTION CONTRACT is entered into this date by and between DunRoamin' Stray and Rescue Inc., hereinafter known as "DR" and the applicant(s) identified in the adoption application, hereinafter known as the "ADOPTER," for the adoption of the above-identified pet.

**TERMS AND CONDITIONS**

1. The adopter agrees to pay DR an adoption fee of \$\_\_\_\_\_ which is non-refundable. \_\_\_\_\_
2. The adopter agrees to provide the pet with a good and safe home with proper care and attention. The pet is not to ride loose in the back of a pick-up truck and is not to be chained outside unattended. When the pet is outdoors, he/she will be provided protection from the elements. This animal is being adopted as a house pet, a companion animal, as such will spend the majority of their time indoors with family. \_\_\_\_\_
3. Cats or dogs adopted from DR will not be allowed to run free or "at large" and must be supervised when outdoors. Cats are adopted to be "house cats" only. \_\_\_\_\_
4. The adopter agrees that this pet will be examined by a licensed veterinarian at least once a year and will receive adequate vaccinations to ensure good health. \_\_\_\_\_
5. The animal has been spayed/neutered, OR will be spayed/neutered when the pet attains the appropriate age or medical situation to allow the procedure. If adopting a cat, the cat **SHALL NOT** be declawed. \_\_\_\_\_
6. In the event that DR discovers the inhumane treatment of this pet or breach of this contract, it is agreed that DR has the right to immediately re-take possession of the pet. It is understood that home visits may be made to check up on the welfare of this animal. \_\_\_\_\_
7. DR makes not statements or warrantees regarding the pet's future health, medical status, or temperament. Information will be provided by DR as to the known health history of this animal but as the animals have been rescued, their past is usually unknown. \_\_\_\_\_
8. DR recommends that, prior to adopting animals of unknown health history, adopters ensure that their current pets are well vaccinated. \_\_\_\_\_
9. It is further agreed that environmental changes may affect the temperament of the above named pet and that DR has no liability or responsibility of any nature regarding later defects with the pet or injuries or damage to any person or property cause by the pet. \_\_\_\_\_
10. In the event that is is determined by DR or the ADOPTER that the pet should not remain with the ADOPTER, it is agreed that the pet shall be returned to DR by the ADOPTER. The pet may not be transferred to another owner without the express written consent of DR. DR is available for consultation, advice and assistance in all areas pertaining to the health, training, compatibility, etc. of the adopted pet. THE ADOPTER UNDERSTANDS THAT DR

HAS INVESTED A GREAT DEAL OF FINANCIAL AND PERSONAL RESOURCES INTO THE CARE, RECOVERY, TREATMENT AND PLACEMENT OF THIS PET, AND EXPECTS THAT THE ADOPTER, ALONG WITH DR, MAKES A COMMITMENT TO THE PET FOR LIFE. \_\_\_\_\_
